We write to provide an update on the current construction works taking place at the above address.

The works entail the first phase of construction for the provision of a new five storey building plus basement. This phase of works includes the construction of the basement level and ground floor slab which has a programme up until Spring 2017.

So far we have cleared the site and have commenced the piling works. Following this, excavation works will take place and then the formation of the basement slab.

Inevitably, as with any construction site some noisy works will be created, however we will ensure that these works will be limited and kept within the construction noise limits and working hours as set by the London Borough of Camden.

The access road to the Globe Tennis Club, adjacent to the site, will be kept clear and access will be uninterrupted at all times. If, for any reason, that access will need to be restricted for a short period of time, then we will of course provide adequate notification to you. This would only happen in exceptional circumstances.
