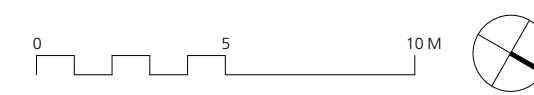
2 Key Plan

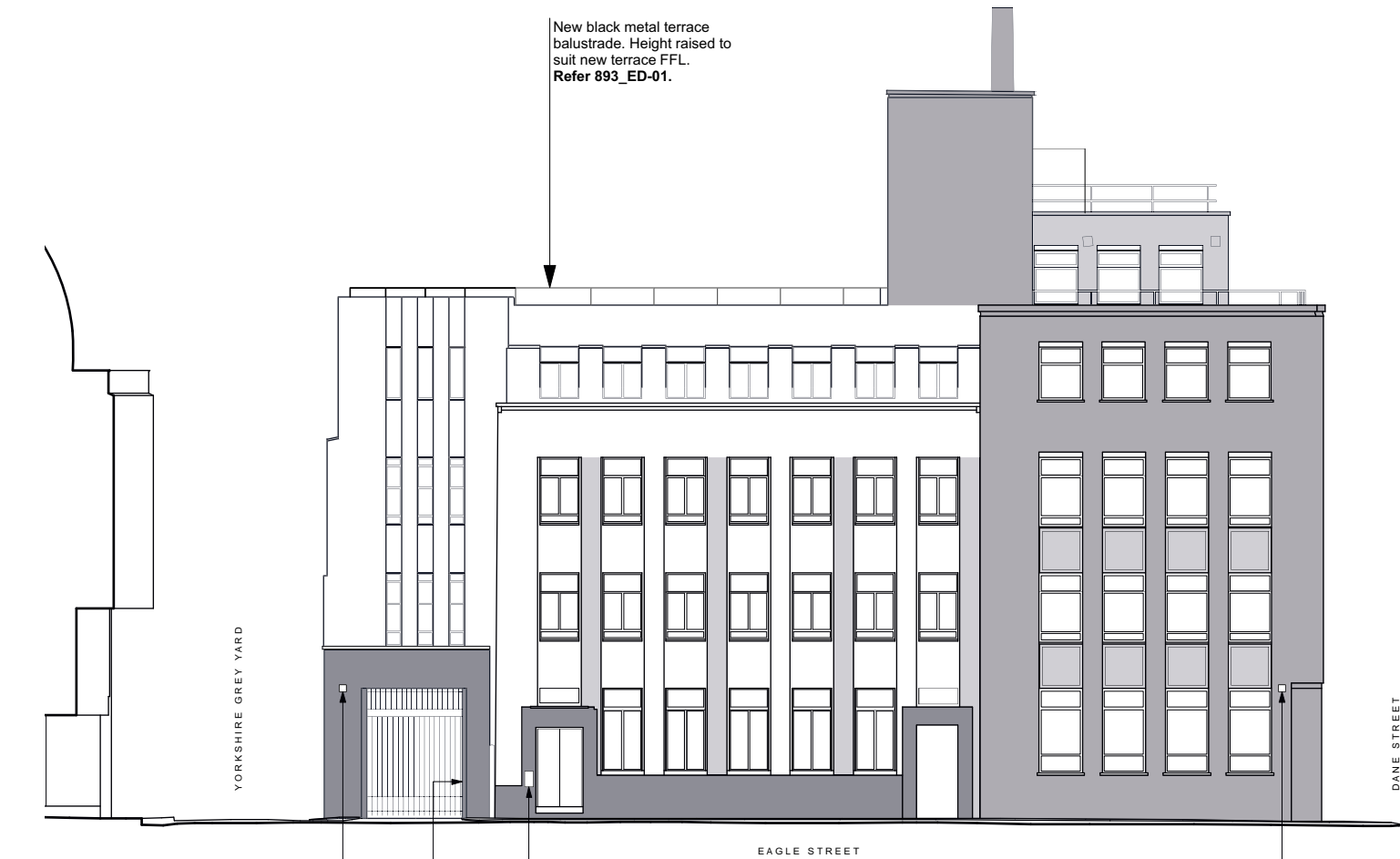
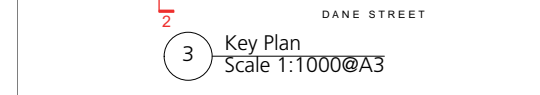
2 Key Plan

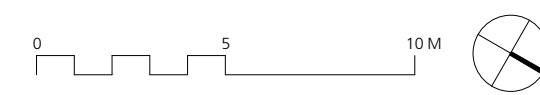
1 Proposed North Elevation (Red Lion Square)

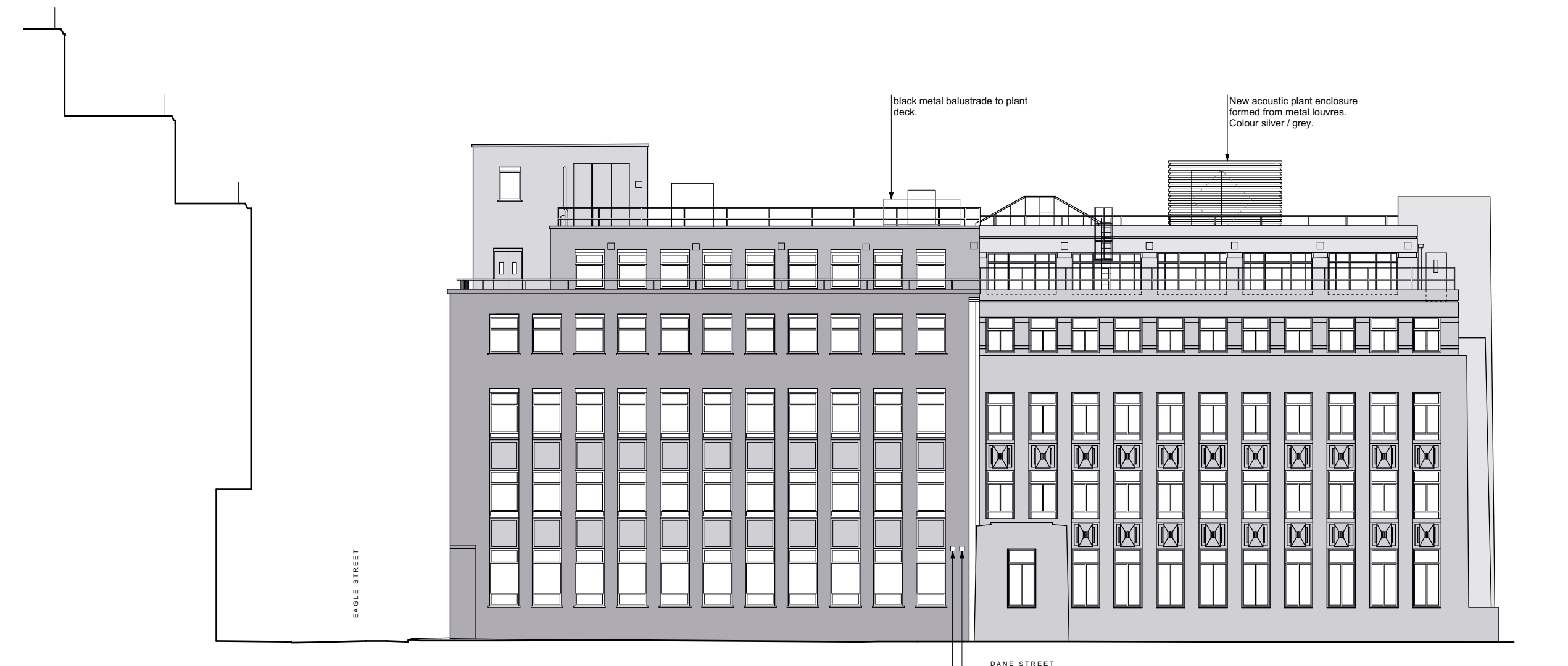

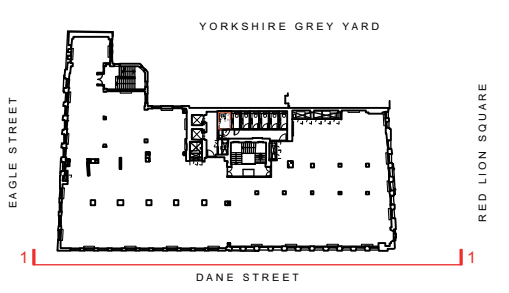
2 Proposed South Elevation (Eagle Street)

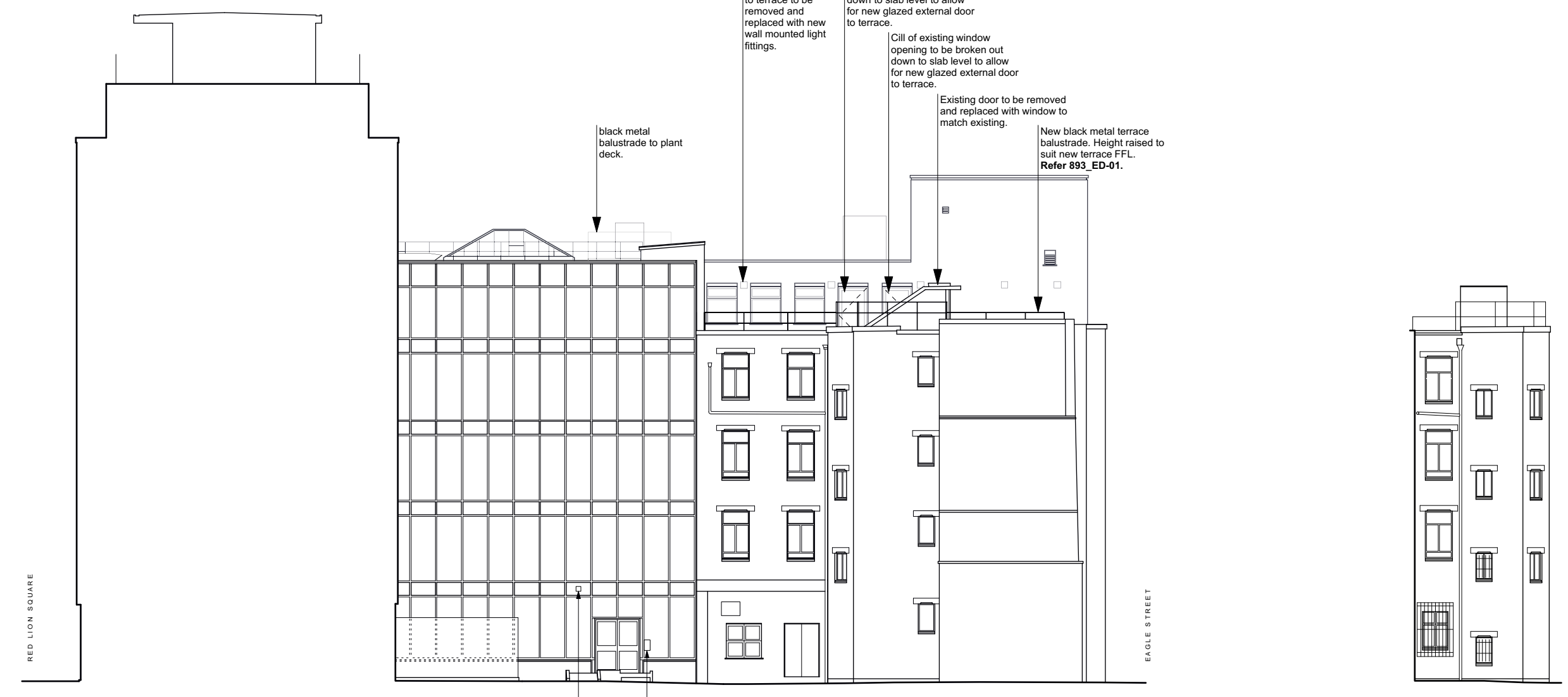

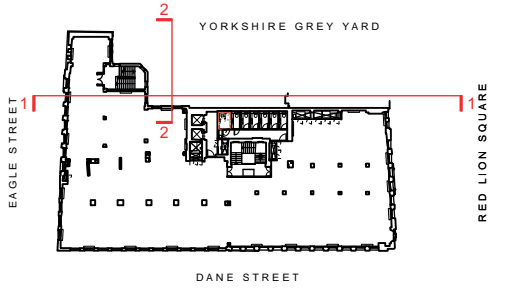
1 Proposed East Elevation (Dane Street)

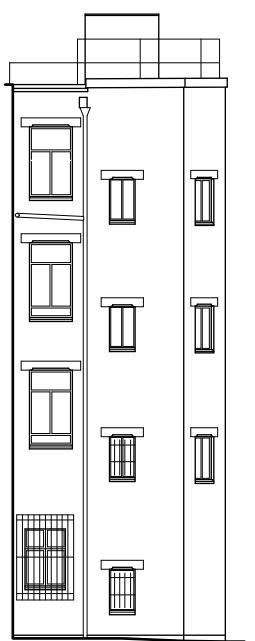
1 Proposed West Elevation (to Lightwell)

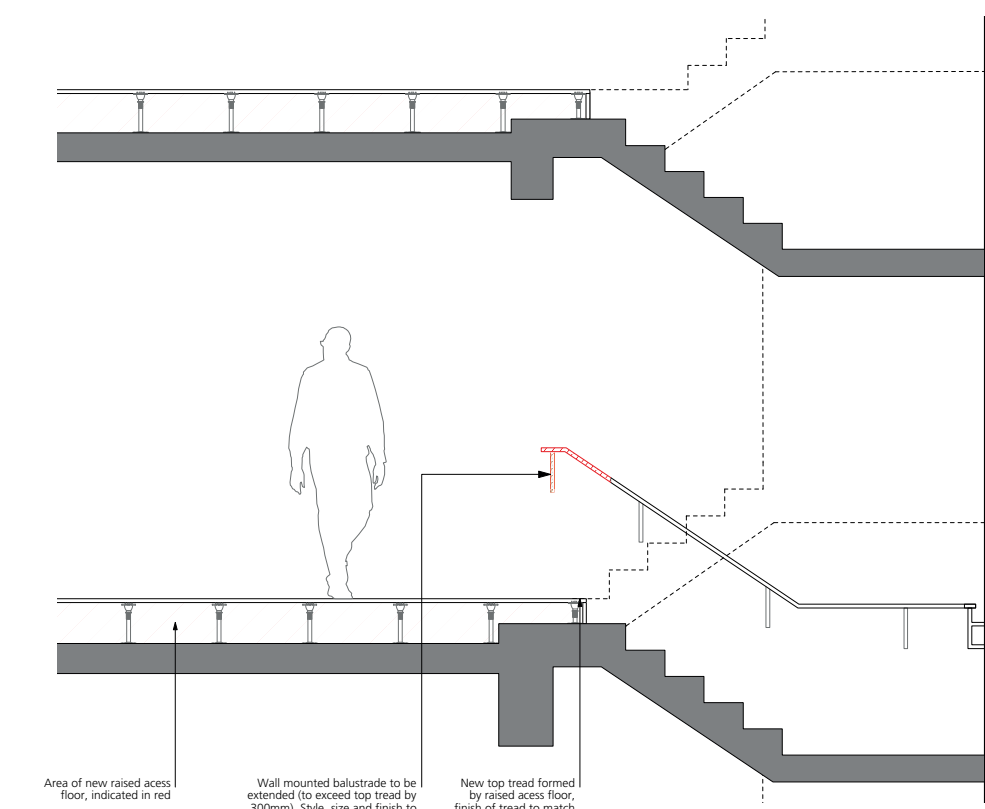

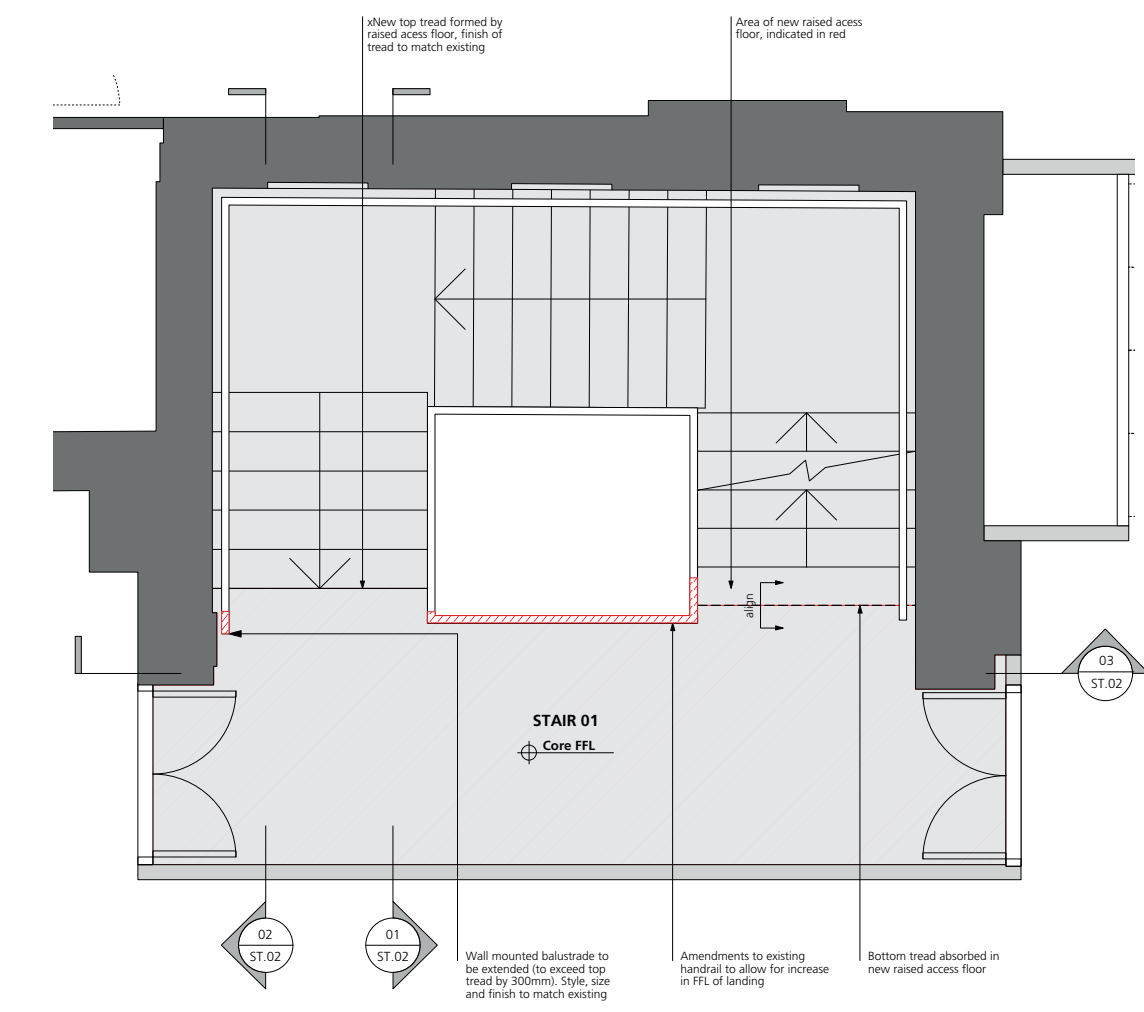
1 Proposed Section A: Typical Floor

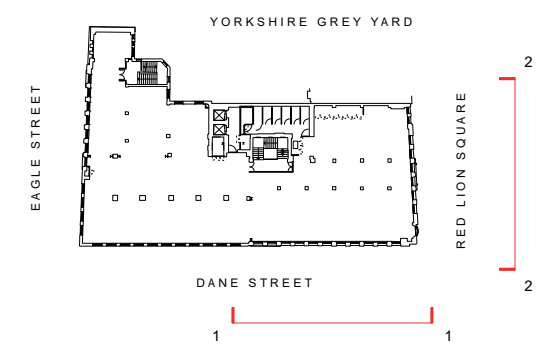

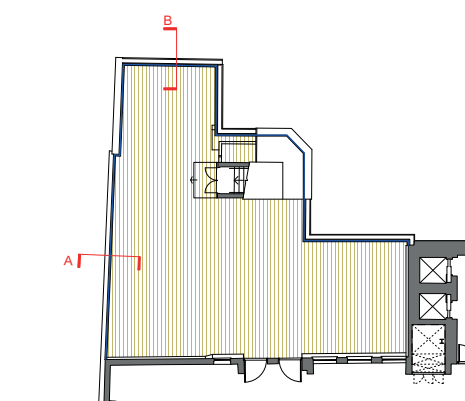
5 Typical Balustrade detail
