REAR garden with side access

T1 & T2 = 2 x Large Self Seeded SYCAMORES - Trees are very close to the mature trees and have no room for future development - fell and grind out stump to 150mm below existing ground level.

T3 = Large PRUNUS - Tree is in slight decline and has a lean in search of light. It also is sighted under the canopy of well-established mature trees and has no room for future development.

We advise - fell and grind stump 100-150mm below existing ground level.

GRP1 = Medium mixed HYDRANGER & RHODODENDRON - fell and grind stumps to 150mm below existing ground level.
