T1 = Large PLANE (on camden park road frontage) - remove 4 x lowest limbs to allow high sided vehicular access (see picture 1)

T2 = Large MAPLE - fell as close as possible to ground level and leave stump at 1.5m high

T3 = Large CHERRY - Reduce crown height by 1.5-2m, reduce lateral branches by 1-1.5m, pruning back to suitable growth points, leaving shortened selected secondary growth to form a smaller neater symmetrical shaped canopy.
