Informative(s):

1 The submitted information confirms that chartered structural engineers have been appointed to oversee the basement construction works. The engineers have the relevant MIStructE and MICE qualifications which comply with the requirements of Camden Planning Guidance (CPG4 - Basements and lightwells). The details



submitted are therefore sufficient to discharge condition 4 of planning permission 2013/6418/P dated 31/03/2015.

As such, the proposed details are in general accordance with policy CS14 of the London Borough of Camden Local Development Framework Core Strategy, and policy DP27 of the London Borough of Camden Local Development Framework Development Policies. The proposed development also accords with policies 7.4 and 7.6 of the London Plan 2011; and paragraphs 14, 17, 56 -66 and 126-141 of the National Planning Policy Framework.

2 You are reminded that condition 7 (method of Grouting details); of planning permission granted on 31/03/15 reference (20136418/P) is outstanding and require details to be submitted and approved; and condition 05 (Trial Pits details) decision pending.
