T1 Sycamore x 1 (*Acer pseudoplatanus*) Large, mature, pollarded tree. Lastpruned in 2012. To prevent over dominance in the front garden and to maximise the light, the suggested works are: To repollard the tree to the most recent pollard points, clean out crown, remove deadwood. T2 Cypress x 1 This tree is growing in to the Sycamore. The suggested works are: To reduce the height by 1.5m, trim all round to shape and contain. T3 False Acacia x 1 (*Robinia pseudoacacia*) Early mature tree. The tree is in close proximity to the property. The tree will get much bigger and it is the wrong species to be this close to the property. The suggested works are: To fell to ground level by sectional takedown. T4 Cherry x 1 (*Prunus* spp) Mature tree. The tree has been suppressed and this has caused a limb to grow for the light. The limb is overlong and out of proportion with the rest of the crown. The suggested works are: To reduce the overlong limb to the South by 2-2.5m. T5 Pear x 1 (*Pyrus communis*) Large, mature, leaning tree. The tree has a decaying cavity at ground level on the Southern (tension side of the tree) side. To reduce the mechanical loading on the tree, the suggested works are: To reduce the height and the lateral spread all round by 1.5 - 2m, clean out crown, remove deadwood.
