2016/6069/P	Emma Gorman	4 Laxton Place	13/04/2017 23:57:58	OBJ	<p>The revised planning statement March 2017 still does not address the key points of my original objection and the developer has used consultants' reports to try to provide counter arguments that still do not address the main concerns of my objection</p> <p>The loss of such social infrastructure also goes against the Euston Area Plan adopted 2015 and developed in partnership with the GLA, which states: "Social infrastructure 2. Provision of new and replacement facilities to meet needs generated by development There are a variety of community facilities in the Euston area, which provide a range of services to the local community. Developments will be expected to make appropriate contributions towards the improvement, maintenance and (where appropriate) expansion of existing community facilities and services in order to address additional needs reflecting London Plan and Camden planning policies. Any community facilities affected by development proposals should be reprovided in the locality."</p> <p>There are no proposals to either save the church or make provision for its replacement. The Mayor's Social Infrastructure SPG also highlights that: 'Boroughs should ensure that the needs of their current and projected population can be met before losing existing social infrastructure.'</p> <p>Planning Application 2016/6069/P does not make any reference to such requirements, nor does it address how it should be replaced. I would also like to highlight that the application's Socio Economic Assessment notably does not mention the loss of social infrastructure.</p> <p>The daylight, sunlight and overshadowing study dismiss the use of our garden at certain times of the year, when we, and especially or disabled son, would benefit from this amenity. The over shadowing of the proposed residential and the overlooking and loss of privacy has not been adequately addressed and still does not meet assurances made to us by British land that we would not lose privacy or suffer form overlooking as a result of the development. We dispute the claims that the studies demonstrate that the Proposed Development would not give rise to an unacceptable level of harm with regards to any potential daylight/sunlight and overshadowing impacts. The application asks for deviation from BRE guidelines for the benefit of the application without proper and robust evidence. We, and the planning officers, have been lied to.</p> <p>Further the Socio Economic Benefits assessment fails to assess the loss of the churches congregation to local business and as such is flawed in its appraisal.</p> <p>In conclusion I continue to object and wish to be able to voice my concerns at the planning committee.</p> <p>E Gorman</p>
