Erection of a rear dormer roof extension and 2 rooflights to rear roofslope; installation of 2 rooflights to front roofslope; fenestration alterations and provision of Juliet balcony at rear second floor level, all to existing residential flat (Class C3).

- 1 The development hereby permitted must be begun not later than the end of three



years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

- 2 The windows located on the proposed dormer extension at roof level shall be timber framed casements and all the other new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy and policies DP24 (Securing high quality design) and DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies.

- 3 The development hereby permitted shall be carried out in accordance with the following approved plans:- Plan showing existing sections; Sk.1B; SK.2 (excluding the proposed roof plan); SK2-showing existing rear elevation; SK.2x1; 12071 Revision A; Design and access statement by J Atkins, Strachan Design Associates Ltd.

Reason: For the avoidance of doubt and in the interest of proper planning.

- 3 Reasons for granting permission.


The proposed development is in general accordance with the London Borough of
