The proposal is the installation of 1 x 0.3m transmission dish mounted on new pole mount on side of rooftop plant-room (14m). The dish is proposed as part of Airwave's Kilostream Replacement Project, which will provide a network of microwave links between existing Airwave base stations using line-of-sight dish antennas. This work will ensure that, in event of a network failure, dish sites would continue to provide full communications coverage for the emergency services.
