To be honest I don't think anything really has changed. It was always my intention to build a green turf roof. I think the problem was that I was unsure of the depth of the substrate. In the original drawings - drawings 5,6,7 and 8 - the green roof is stated as having a thickness between 5cm and 15cm. I am now going to build a roof with a 15cm depth - as you will see from the submitted extra drawings. This will enable me to put a wildflower turf on the roof.

The only other change - apart from building the roof to the maximum thickness on the previous plans is a slight shifting in the positioning of the skylights which will now be regularly spaced rather than slightly irregularly spaced. I enclose a drawing of this change which is almost imperceptible.
