We bought this flat in March 2014 and the conservatory we inherited is aged (it was built in 1979 and has lived its time). We are seeking planning permission as we are looking to replace the current single glazed glass in our conservatory with double glazed glass. No change of use proposed. Note the conservatory is located in the rear of our property.

FYI - we plan to replace the current timber conservatory for a new one as the current conservatory is aged and water drips through the roof and the side window panels when it rains, plus it is not heat proof so gets extremely cold in the winter rendering it unusable in the winter months and akin to a green house in the summer. The conservatory serves as our dining area and is attached to our kitchen. We plan to replace the existing timber frame with timber and we plan to keep to the same footprint. The only change being we propose to replace single glazed glass with double glazed glass and we are applying for planning permission to be able to change the single glazed glass with double glazed. This will enable us make the conservatory and the rest of our flat energy efficient. It will also improve safety as the current glass is easily breakable and is not toughened.


