(Please note, this has been discussed with James Remmington.)

We propose to completely remove this Loquat/Japanese Plum tree and replace it with a new tree or two, such as a thin silver birch (the new tree would be about 3 metres tall). The current tree was historically kept quite small -- in an ornamental capacity -- and then was badly managed for several years. As a result, it has grown much too large for the space and is blocking a lot of light and views to both no. 21 and no. 23. It's also not an attractive tree, and after discussion it was considered best to remove it and replace it with something more attractive, and a variety with less thick foliage.

There is no TPO currently on the tree.
