After consultation with Nick bell at Camley street natural park we showed him two trees we are concerned about, he aggreed that we should take the following actions:

1. Willow tree requires pruning down to original level to prevent the tree over weighting and falling in the wind.

2. Elder tree with fungal infection in the base of the tree needs chopping down to prevent it falling over and harming young children
