1 Reasons for granting

Condition 7 requires the submission of details and a method statement for the retention and use of the glazed roof to the palm court, including corresponding detailed photographs and drawings of the existing roof once it had been uncovered.

The information submitted is considered acceptable and the proposal has been inspected on site by a conservation officer.

The proposed details are in accordance with policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP25 of the London Borough of Camden Local Development Framework Development Policies. The proposed development also accords with the London Plan 2015; and the provisions of the National Planning Policy Framework 2012.

- 2 You are reminded that you still have the following conditions to discharge from the parent permission 2015/1673/P; Condition 6 (Rest of details of drawings and samples) and Condition 8(Columns).
- The emerging London Borough of Camden Local Plan is reaching the final stages of its public examination. Consultation on proposed modifications to the Submission Draft Local Plan began on 30 January and ended on 13 March 2017. The modifications have been proposed in response to Inspector's comments during the examination and seek to ensure that the Inspector can find the plan 'sound' subject to the modifications being made to the Plan. The Local Plan at this stage is a material consideration in decision making, but pending publication of the Inspector's report into the examination only has limited weight.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraphs 186 and 187 of the National Planning Policy Framework.
