T3: Cherry: Approximately 14.00m. Fell to ground level. Reason - Poor specimen and client wishes to replant with more suitable specimen.

T4: Lime: Approximately 14.00m. Remove dead wood and thin crown by 20%.

Reasons: General maintenance unless otherwise stated.
