T2 Pear x 1 (Pyrus communis) Mature tree. There is a low limb growing to the Southeast that is causing a Himalayan birch to lean. The suggested works are: To reduce the low limb back by 2.5 - 3m to clear the birch tree. T3 apple x 1 Mature, suppressed tree. Most of the crown is over the neighbours garden. To reduce the encroachment, the suggested works are: To reduce the lateral spread to the Southwest back by 1 - 1.5m. T4 Judas Tree x 1 Partially windthrown across the boundary wall. The suggested works are: To fell to ground level. T5 Persian Ironwood x 2 (Parrotia persica) To improve access around these two trees and to maximise the light, the suggested works are: To crown lift all round to 2m above ground, thin through the crowns by 10 - 15%, remove deadwood. T6 Weeping Willow x 1 (Salix alba 'Tristis/babyloni ca) Mature tree. The tree has been propped to prevent failure. To lessen end weight and reduce mechanical loading, the suggested works are: To reduce all round by 1m, thin through the crown by 5%, remove deadwood.
