Dear Linda,

It was good to speak with you earlier. It seems as though Mark has been liaising with Libby Beaumont about whether you need to obtain PP.

The installation of the notice board would be development that needs planning permission. As you might be aware some development is 'permitted' and can take place without making an application to the council (e.g. minor development for householders, works carried out by a local authority). In this case it is possible that the noticeboard could be 'permitted development' but for this to be the case it must be positioned on our land, installed by us, maintained by us and in connection with a public service we provide. I think it might be a bit tricky to argue this is the case, but I don't want to make life difficult for you when you are trying to move forward with a positive scheme which is going to benefit local people in this area. My suggestion would be to make an application, but that we will waiver the fee for you and seek to process it as quickly as possible. We have to advertise (minimum) so there is a limit to how quickly we can do this, but we can certainly expedite it.

If you could let us know when the application is on its way we will make sure it is allocated promptly. I suggest that you put a copy of this email within the submission so it is clear that I have agreed to waiver the fee for you. I have copied in Alex Bushell the team manager who covers this part of the borough so he is aware.

As part of your submission I suggest you provide an OS Map showing the site, a scaled plan which shows where it is to be positioned. Some images of the board, we need to know its dimensions and perhaps a short supporting statement which explains the project.

I hope that helps and I wish you all the best with your project.
