## Town and Country Planning Acts 1990 (as amended) NOTIFICATION OF AN APPEAL

The Council has been notified of an appeal against an enforcement notice which has been made to the Planning Inspectorate.

The appeal concerns property at:

Flat Ground Floor 16 Mackeson Road London NW3 2LT

and the breach of planning control alleged in the enforcement notice is:

The unauthorised replacement of timber windows with uPVC at ground floor level to the front elevation, the unauthorised replacement of timber windows and door with uPVC windows and door to the rear elevation at lower ground level, the unauthorised creation of a new window opening and fitting of uPVC window to the side elevation at lower ground floor level, the unauthorised replacement of a timber window to the existing lower ground side elevation with uPVC, the unauthorised removal of a timber window and installation of a uPVC door at upper ground floor level and installation of railings to create a roof terrace at rear upper ground floor level.

Grounds of Appeal

The appellant/s have appealed on the following grounds:

a) That planning permission should be granted for what is alleged in the notice.



b) That the breach of control alleged in the enforcement notice has not occurred a	as a	ma	ıtter

c) That there has not been a breach of planning control.

- d) That, at the time the enforcement notice was issued, it was too late to take enforcement action against the matters stated in the notice.
