Rear garden - trees in conservation area, work recommended as good management

1) Pear - Reduce to former pruning points and thin by 10 - 15%.

2) Pear - Prune to give a more balanced shape following loss of top, thin 10 - 15%

3) Apple - Prune to give a more balanced shape after removal of climbing plant

4) Pear - thin regrowth from pruning points by about 30% to favour the stronger shoots from previous reduction

6) Pear - Reduce to former pruning points and thin by 10 - 15%.

Front garden

8) Copper beech (only TPO tree) - Very one sided due to growing under an ash in the next garden. Shorten the longer shoots extending over the garden by up to 3m to give a more balanced shape
