## DECISION

Town and Country Planning Acts 1990 (as amended) Town and Country Planning (Tree Preservation Order) Regulations 1999 GRANT CONSENT FOR WORKS TO TREE/S UNDER A TREE PRESERVATION ORDER

Proposal: To fell 1 x Ash - (TPO ref. C2003 2014) and replace.

The Council has considered your application dated 08 February 2017 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Council to monitor the completion and standards of the work.

2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the



tree(s).

3 During the first available planting season following the completion of works, a Sweet gum (Liquidambar styraciflua "Worplesdon") tree shall be planted as a semi-mature tree with a girth size of 20-25cms, unless otherwise agreed in writing by the local authority. The tree shall be planted and maintained to the standards set out in BS8545:2014, close to the location of ash tree with the exact location to be agreed on site. Any trees or areas of planting which, within a period of 5 years after planting, die, are removed or become seriously damaged or diseased, shall be replaced as soon as is reasonably possible and, in any case, by not later than the end of the following planting season, with others of similar size and species, unless the local planning authority gives written consent to any variation.

Reason: In order to comply with the provisions of Section 206 of the Town and Country Planning Act 1990 (as amended).

1 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
