T2 = Medium PORTUGUESE LAUREL - Reduce crown height by 2m, reduce lateral branches by 1.5m, pruning back to suitable growth points, leaving shortened selected secondary growth to form a smaller neater symmetrical shaped canopy.

T3 = Large EUCALYPTUS - Reduce crown height and lateral branches by 2-2.5m, pruning back to suitable growth points, leaving shortened selected secondary growth to form a smaller neater symmetrical shaped canopy.

T4 = Large BIRCH - Remove trunk growth (co-dominate limbs) and cut back from building to give a 2m clearance.

T5 = Large BIRCH - Remove trunk growth (co-dominate limbs) and cut back from building to give a 2m clearance.

T6 = Large HOLME OAK - Cut back from garage to give a 1m clearance of garage.

T7 = Large BAY - Cut back from garage to give a 1m clearance of garage.

7. Identification Of Tree(s) And Description Of Works

T8 = Large SYCAMORE by garage - Reduce crown height and lateral branches by 2-2.5m, pruning back to suitable growth points, leaving shortened selected secondary growth to form a smaller neater symmetrical shaped canopy.
T9 = Large HAWTHORN - Reduce crown height and lateral branches by 0.5-1m, pruning back to suitable growth points, leaving shortened selected secondary growth to form a smaller neater symmetrical shaped canopy.
T10 = Large Twin Stem CATALPA - Reduce crown height and lateral branches by 1.5-.2m, pruning back to suitable growth points, leaving shortened selected secondary growth to form a smaller neater symmetrical shaped canopy.
T11 = Large MALUS - Reduce crown height and lateral branches by 1.5-2m, pruning back to suitable growth points, leaving shortened selected secondary growth to form a smaller neater symmetrical shaped canopy.
T12 = Large ROBINIA - Formative Prune.
T13 = Medium PRUNUS SPP - Formative Prune.
GRP1 = 7 x Large SYCAMORES - Reduce crown height and lateral branches by 1.5-2m, pruning back to suitable growth points, leaving shortened selected secondary growth to form a smaller neater symmetrical shaped canopy.
