Site at Hawley Wharf, Land bounded by Chalk Farm Road, Castlehaven Road, Hawley Road, Kentish Town Road and Regents Canal, London, NW1 Discharge of Conditions 18(f), 19 (c) and 19 (d) (Planning Permission 2012/4628/P)

We write on behalf of our client, Stanley Sidings Limited, enclosing an application for the discharge of Conditions 18(f), 19 (c) and 19 (d) attached to planning permission 2012/4628/P.

## Condition 18 (f)

Condition 18 (f) is worded as follows:

"With regard to the residential building fronting Castlehaven Road (C1 building), detailed drawings, or samples of materials as appropriate, in respect of the following, shall be submitted to and approved in writing by the Council before the relevant part of the work is begun:

f) Typical details of all arch frontages including jambs, head and cill, including materials and finish at a scale 1:10."

Accordingly, we enclose drawings (ref: 14045\_VX\_(31)\_1010 and 14045\_VX\_(31)\_1011) which demonstrate the typical detail of all arch frontages including jambs, head and cill, including materials and finish at 1:5 scale. The architects have confirmed that the drawings have been drawn at this scale in order to convey the required level of detail at this stage in the project.

## Condition 19 (c)

Condition 19 (c) is worded as follows:

"With regard to the triangular building in Area C (C2 building) detailed drawings, or samples of materials as appropriate, in respect of the following, shall be submitted to and approved in writing by the Council before the relevant part of the work is begun:

c) Typical details of all shopfront and communal entrances including jambs, head and cill, including materials and finish at a scale 1:10."

d) Typical details of the service area enclosures including jambs, head and cill, including materials and finish at a scale 1:10."
