The Noise already affects our sleep. My husband works long shifts doesn't get a full 5 hours sleep. The noise of these air conditioners if allowed to go ahead will make or current poor health suffer further. We live in low ceiling flats where we r exposed to noise of neighbour, where u can hear doors, conversation, use of toilets, dog barking , children playing, crying, with no where to hide as the flats are small . No with the added noise of six air conditioners we certainly will go mental. As the mind and body requires rest. Please also note in these very small flats we live without fans or air conditioners. Also we are paying very high full council tax (not on any benefits) we are suffering for space pay full rent.and work to pay rent and council tax , we have no where to go or rather can't afford it after paying the bills .
