Horsechestnut tree in raised garden facing A502 Haverstock Hill to fell. The tree is infected with *Pseudomonas syringae* which has caused the death of bark around the entire circumference of the trunk of one stem of the twin pair of stems that arise just above ground level. There is every likelihood that the second stem will become infected soon. Removing only the dead stem will leave the tree unbalanced and with a very limited future life expectancy as a large wound will have been created. It would be preferable to remove the entire tree and plant a suitable replacement.
