Mansard roofs covered with natural slates (Delabole) with lead flashing details and ridge tiles.

Quilted 12mm insulation to be fitted to existing roofs and treated softwood counterbattens fitted, and roofs completely re-slatted with new 'Silverstone' Spanish Natural Slates with all new leadwork to match existing. Profile of roof to be maintained.

To mansard storey, double hung timber sash windows, each sash having four lights, and set within timber dormer structures covered with lead.

New double hung timber sashes to be fitted, with double glazing, and dormer structures to be insulated and covered with new Code 5 lead sheet to top, front and cheeks and Code 4 lead apron beneath.
