Dear David,

I have examined the plans and know the site well, and wish to offer my support for the proposal connected with the above planning application for the following reasons.

It fits well with the declared Camden Plan and is supportive of the council's own plans and strategy. Firstly, The Lighthouse would be a superb example of developing a new solution with a partner to reduce inequality. Lighthouse will be open to all and looks to address issues of physical, emotional and spiritual health and wellbeing - it is specifically intended as a response to the urgent social need in the local community. With established and respected projects and partnerships aimed at supporting disadvantaged children and young people and addressing issues for unemployment, it reaches to the roots of many of the causes of inequality experienced by those in the borough. In addition, with its open to all policy, it is intensionally looking to overcome or bridge social and cultural divides, promote the true values and meaning of community, and to make a positive difference to people's lives. Lighthouse and its partner projects impact health, education and criminality in the borough, particularly amongst the young, and are proven long-term solutions to costly problems (e.g. XLP). Secondly, the project contributes towards creating conditions for and harnessing the benefits of economic growth. The council's desire to 'bridge the gap between the employment opportunities available in Camden and the increasing levels of unemployment, particularly amongst young people, is an outcome of Lighthouse's partner projects (e.g. SPEAR). Thirdly, the project is an investment in our community to ensure a sustainable neighbourhood. Community cohesion is incredibly important for strong and resilient communities to take

responsibility for themselves, at a time when the public sector is downsizing and due to financial constraints to do less and less. Acting as a hub for the community, a meeting place, a place of refuge, help and support, as well as place of worship, will encourage community interaction and collaboration. Fourthly, the project offers value for money and given the experience being brought to the initiative, will get it 'right first time.' Lighthouse and its partners have experience of delivering services to a high standard of quality and offering good value for money particularly given the sources of funding. The Camden Plan looks for a 'vastly different way of working' and an ambitious plan of 'working with both the community and partners'. The Lighthouse project offers all of this and more, working with partners who are already highly experienced with working in Camden and with a core team who have lived in and been committed to the borough for many years.

In addition to fitting well with the Camden Plan, and of particular relevance to XLP the charity for whom I work and a partner of the Lighthouse project, Lighthouse will provide an excellent platform for the charity and the other partners to deliver much needed services to children and young people growing up in the borough. XLP would look to use desk space within the facility as a base for planning activities and general meetings, meeting rooms for sessional work with groups of young people (e.g. group mentoring sessions, workshops and alike), studio and auditorium space for arts based youth activities and events that look to engage with both young people and the broader local community and families. We would look to work with between 150 and 200 children and young people in 1-2-1 and small group work, and engage with 300 - 400 if larger events are included in the numbers. The goal of our work delivered out of Lighthouse would be to support children and young people in choosing to:

- a) stay in or return to school and do well;
- b) stay away from or get out of gangs, crime and ASB; and,
- c) set goals and work hard to achieve them.

We are currently delivering projects with a number of schools/PRUs with the borough, have our XL-Community Bus project delivering sessions on estates in Camden, operate the Arts Showcase project there in partnership with local schools and communities, and take young people from Camden on summer camps outside of London.

I offer my full support for the proposal connected with the above planning application.
