Planning application for change of use at 52-53 Russell Square - Strong objections from residents of 54 Russell Square
The residents of 54 Russell Square are completely opposed to this proposed change in use.

It is completely unnecessary as the landlord, Bedford Estates, feel they should be able to find an Office tenant by 2019 when the current lease expires. If the proposal were to be allowed, a secondary school with four times the number of occupants would be bound to have a major impact on our residential enjoyment of the property, on the fragile tranquillity of the a major impact on the insignite and insignite in the property of the major and antiquinity of the square and adjacent public realm, and will generate substantially more traffic congestion and pollution than the proposal suggests. There would have to be major changes to the Grade 11 listed building – which the proposals suggests disingenuously would not be needed and further there are very serious fire, safety and security issues which greatly concern residents. This proposal should be rejected outright.

Background

The southerly row of houses 52-58 were originally built as residential property in approximately 1806. Over the years, they have been used as a mix of residential and office accommodation. They are currently used as office accommodation. They are currently used as office accommodation. Institutions and public bodies such as the Mathematics Institute and other organisations have made good use of them and could continue so to do, but they are entirely not fit for use by a secondary school with 180 youngsters.

A change of use is entirely unnecessary

Our first point is that a change of use is completely unnecessary.

We have spoken with Bedford Estates who say that they should be able to find a commercial tenant by January 2019 when the current lease expires. The Loss of Office report has been prepared when the property had only been on the market for 4 months and there had been some interest already. In the 20 months that remain before the lease expires it is highly likely that a new tenant can be found who will not bring major disruption, reduce employment, and

attempt to use a building for a purpose it is completely unfit for.

The office use was initially grant temporarily during the war for 25 years with the proviso that it returned to residential after that time, if now office use is no longer viable there should be a change back to permanent residential as required by the Council's policies. Many commercial properties in the area are being returned to residential use and there is no evidence that this has been explored in any form as an alternative.

3. The building is entirely unfit for use as a school building and represents a fire hazard

The building is entirely unit of use as a school for over 200 staff and students. It is an historic building with original plaster and lathe wall linings and ceilings. The floors are timber with separate ceiling and floor supports which results in substantial voids in the floor construction again providing a concealed route within which fire can spread very quickly. The internal walls are similarly timber stud and lined with lathe and plaster again providing a fire route though the internal void spaces. This would represent a major fire hazard for this number of people. The building has one narrow twisting central staircase serving the four floors and an emergency escape through our loft space – which under the terms of our lease is used for storage. workers, it must be very suspect for a school of 200 young school students. With the historic fabric having inherent compromises it is considered that young lives should not be exposed to these risks. There is no external space for the children to be accommodated on the site and Fire Drills are likely to be required on a regular basis and it would be further dangerous to have 200 distressed students discharging from the building directly onto the busy mads that surround the building and the Square.

4. To be used as a school, the building will require very significant building changes and the statement in the submission that The proposals will not result in any internal or external changes to the building' range be true.

changes to the building cannot be true.

It is a complete misrepresentation to suggest that the building will not need to be altered to be used as a school. There are a myriad number of issues that will need to be addressed from public areas through to toilets and catering. The proposal will result in the occupancy numbers going from 50 to over 200 – a fourfold increase – so either the current building had four times the facilities it needs, or significant changes are needed.

Further, when this school took occupancy of the site they currently occupy in Bedford Square they immediately made changes to the school without permission – so they have a track record of ignoring planning regulations.

- proposed would also affect the legal status of the escape route which we find unacceptable.

 6. It would greatly increase traffic congestion and pollution as it currently does in Bedford Square to suggest otherwise cannot be true

The transport report submitted in support of the application is, in our view, entirely misleading. It suggests that vehicle trips will remain at much the same level and proposes this through a theoretical analysis. The reality is that the school in Bedford Square has many students being dropped off by car in the morning and picked up in the evening. They block the road and park illegally and the school makes no effort to manage the situation. There is virtually no vehicular traffic for the current users of 52-53 Russell Square at any point during the day. Rather than a theoretical analysis, there should be an actual survey of the drop off mombers at the Bedford Square site at the start of the school day and a similar survey of vehicle drop offs at the same time period at 52-53 Russell Square. We attach as an appendix a survey undertaken on the morning of 12th May by us.

Actual data should be used for the purposes of any comparison rather than a theoretical analysis

> There are 5 residential flats in 54 Russell Square occupied by couples past retirement age with one exception. The peace and calm of the setting is a right guaranteed by their lease – that there will be no exceptional noise or disturbance. All the flats share the party wall with 52-53 and whilst quite office workers cannot be heard through the wall, large classes of 30 students engaging in active learning will surely have a massive impact on the peace and quiet within the main living rooms of most of the flats. No amount of sound proofing is likely to be adequate and thus the 'quiet enjoyment' of the property that is currently enjoyed will be completely shattered.

8. It would badly affect the immediate surroundings of 54 and 52-52 Russell Square
Students of this age are not the same as office workers arriving singly or in pairs. Behaviour
at school gates is notoriously noisy and impossible to constrain. Thus every morning and evening is bound to be far, far noisier than current levels.

Further, there is no school playground or space for students to gather and interact in the way that students should. Their only option will be the immediate vicinity – the steps and streets on either side of the building being particularly badly affected.

Russell Square is also likely to be badly affected – it is a public space used by residents and

visitors – it should not be allowed to double as a regularly used school playground.

- 9. Major issues arising from school use have not been addressed

 How will students eat at lunchtime? They are not mature students but young school children

 and there are no plans for catering or other facilities that we are aware of. So whilst office workers eat a sandwich at their desk or go out to lunch in the surrounding area, this is not presumably an option for 180 unsupervised youngsters? How will they eat and what will be the impact on the surrounding area – the café in the square etc.
- 10. It will add nothing to Educational provision in the area that will be available to Camden residents and taxpayers and will remove jobs. It will add nothing to Camden's priority need for more residential accommodation.

This is a proposal for a private International school with high fees. 80% of students come from out of the Borough and none of the facilities are or will be available to Camden residents. It will be a major reduction in employment opportunities within the borough - removing 50 jobs. It will do nothing for Camden's priority need for residential accommodation.

We strongly argue that this change in use should not be granted.

No change of use is needed – confirmed by Bedford Estates, the Landlord. The building is completely unfit for purpose and will pose a major fire hazard. It will have a massive impact on adjacent neighbours, on the atmosphere and use of the surrounding public realm, will bring a

major increase in vehicular traffic and raises many safety and other issues.

Overall, the application completely misrepresents the situation, is completely out of line with Camden planning priorities, and should be refused outright.

Blocking the road and illegal parking are clearly traffic offences.

The children also arrived in a continuous stream by taxi, parental car and zip car, the majority double parked in the single carriageway blocking access for the other commercial traffic. In some cases, 3 or 4 cars at a time but at least 1 per minute. In the case where children were escorted into the building the car owner in some cases parked on the pavement adjacent to

The arrival of the cars at the school clearly involved traffic violations and did cause inconvenience to other road users by completely blocking the road. It should be considered in the case of Russell Square there are double yellow lines and a bus stop at the side of 52 If the case of Nasein Square in Bedford Place, therefore double parking of coaches and drop-off cars would cause greater problems due to the higher intensity of traffic circulation within Russell Square. The amount of traffic using Russell Square involves 10 traffic access points entering or leaving the Square while Bedford Square only has 5.

A large crowled parents also standing on the corner of Russell Square and Bedford Place would limit visibility for turning traffic and make the junction dangerous for pedestrians which we know is a concern to the elderly resident living in 51 Russell Square.

residents of 54 Russell Square The residents of 54 Russell Square are completely opposed to this proposed change in use. It is completely unnecessary as the landlord, Bedford Estates, feel they should be able to find an Office tenant by 2019 when the current lease expires. If the proposal were to be allowed, a secondary school with four times the number of occupants would be bound to have a major impact on our residential enjoyment of the property, on the fragile tranquillity of the square and adjacent public realm, and will generate substantially more traffic congestion and square and adjecting public learning, and win generate substantially lines using the Congestion hopelultion than the proposal suggests. There would have to be major changes to the Grade 11 listed building – which the proposals suggests disingenuously would not be needed and further there are very serious fire, safety and security issues which greatly concern residents.

In the 20 months that remain before the lease expires it is highly likely that a new tenant can be found who will not bring major disruption, reduce employment, and

attempt to use a building for a purpose it is completely unfit for.

The office use was initially grant temporarily during the war for 25 years with the proviso that it returned to residential after that time, if now office use is no longer viable there should be a change back to permanent residential as required by the Council's policies. Many commercial properties in the area are being returned to residential use and there is no evidence that this has been explored in any form as an alternative.

3. The building is entirely unfit for use as a school building and represents a fire hazard

The building is entirely unit of use as a school for over 200 staff and students. It is an historic building with original plaster and lathe wall linings and ceilings. The floors are timber with separate ceiling and floor supports which results in substantial voids in the floor construction again providing a concealed route within which fire can spread very quickly. The internal walls are similarly timber stud and lined with lathe and plaster again providing a fire route though the internal void spaces. This would represent a major fire hazard for this number of people. The building has one narrow twisting central staircase serving the four floors and an emergency escape through our loft space – which under the terms of our lease is used for storage. It is a complete misrepresentation to suggest that the building will not need to be altered to be used as a school. There are a myriad number of issues that will need to be addressed from public areas through to toilets and catering. The proposal will result in the occupancy numbers going from 50 to over 200 – a fourfold increase – so either the current building had four times the facilities it needs, or significant changes are needed.

The peace and calm of the setting is a right guaranteed by their lease – that there will be no exceptional noise or disturbance. All the flats share the party wall with 52-53 and whilst quite office workers cannot be heard through the wall, large classes of 30 students engaging in active learning will surely have a massive impact on the peace and quiet within the main living rooms of most of the flats. No amount of sound proofing is likely to be adequate and thus the 'quiet enjoyment' of the property that is currently enjoyed will be completely shattered.

8. It would badly affect the immediate surroundings of 54 and 52-52 Russell Square
Students of this age are not the same as office workers arriving singly or in pairs. Behaviour
at school gates is notoriously noisy and impossible to constrain. Thus every morning and evening is bound to be far, far noisier than current levels.

Further, there is no school playground or space for students to gather and interact in the way that students should. Their only option will be the immediate vicinity – the steps and streets on either side of the building being particularly badly affected.

Russell Square is also likely to be badly affected – it is a public space used by residents and

It was observed that teachers started arriving at 7-50 and at that time there were half a dozen children and parents waiting on the footpath for the official opening of the were rain a duzer crimiter and perins waiting on the looped in or the crimital opening of the school. Als 200 a member of staff opened the door for the children to enter, no one entered at that time as the students were perhaps waiting for their friends.
