Meeting rooms do not exist, office space is tiny, office space is inadequate, all hampering the growth of the community.</p> <p>Since its re-invigoration ten years ago, this outward looking organisation has done much good work with children in Camden, helping disadvantaged youth find employment, etc. and is wishing to become even more a centre of the community.</p> <p>Lack of facilities is restricting the benefits that this centre can offer the community.</p> <p>Strenuous efforts have been made to assess the needs of the community, and the proposals seek to respond to these needs.</p> <p>The increased facilities for community benefit that the new building would offer compliment efforts being made by the local authority, and, as they will help reduce pressure on the authority, are worthy of the council's support.</p> <p>Serious notice has been taken of pre-application advice from the planning department, and every effort made to accommodate as much of this advice as possible.</p> <p>At the outset of the project, a rigorously competitive interview process was adopted in the selection of the firm of architects, and one selected who went on to win the Stirling Prize for Architecture, a firm whose offices are in Camden.</p> <p>The Finchley Road could benefit from an improvement to its aesthetic qualities, and it is hoped that this opportunity of providing a welcome uplift will not go unrewarded.</p> <p>The current building is small to the point of insignificance, often missed by passers by, not contributing architecturally or socially to the area.</p> <p>The proposed building seeks to provide a landmark, providing both architectural and social benefits far beyond current capability.</p>

We are far too small for all of the activities that we already have in our space, and are in desperate need of expansion.</p> <p>As a local resident, this project will have so many benefits for everyone in the community.</p> <p>First of all, our current building is unsightly and averages down the neighborhood. Finchley Road has much unrealised potential given the sheer number of people who pass through. There is such a need to upgrade vast amount of C-grade retail and business space. The Lighthouse building will be new and interesting, and serve an anchor for desperately needed redevelopment on this part of Finchley Road.</p> <p>Second, the building is designed to serve the neighborhood through the care facilities that are an integral part of the design. The residential facilities will provide much needed space and support for youth coming out of care. If we really care about transforming the lives of the most vulnerable and investing in facilities that very well could lower depravation, crime and homelessness in Camden, we should be encouraging developments such as this one.</p> <p>Finally, the additional space will allow even more community outreach. The Spear and XLP programs now supported at HTSC are evidence of the kind of impact that can be achieved through community-led, faith-based but not faith-biased programs aimed at youth. The accomplishments already achieved are wonderful, and can only multiple with better infrastructure.</p> <p>The church space will also be a great opportunity for community organisations to hold school plays, concerts and the like. We live in a society where we all need to pull together, and having spaces designed for, and driven by, the community is essential.</p> <p>One last note - there are no doubt many technical requirements to have this project approved. I hope the Council adopts a posture of partnership with the church, rather than looking for technicalities as a means of delaying a project that is needed today. I am supportive for the following reasons: - The stretch of Finchley Road around the Finchley Road tube station is in my view particularly unwelcoming from an aesthetic point of view. Part of that is because of the high traffic road (which is unlikely to change) and a bigger part being because of the very low quality and haphazard facades of the various shop fronts and newer buildings. - I have always considered this a real travesty of urban planning in that the underlying fabric of most of the building along that stretch is actually really good; the Waitrose building is exceptional as is the building above Finchley Road tube and the buildings adjoining it traveling North along Finchley Road towards the O2 Centre; the crying shame is that these building have been clad at ground floor level in a hideously unwelcoming fashion - This development in my view will have a very significant positive impact on the surrounding aesthetic environment, really moving the needle towards helping this junction fulfil its true potential. - I could see it act as a stimulus to motivate the building owners between the station and the O2 Centre to redesign their facades and turn what is a B or C grade high street into an A grade retail venue. - The use of the building is also worthy of our support in my view; I think that the community will be stronger and will benefit from its presence. While the church element does not attract me per se, I am very supportive of the many non-church facilities that they are planning to implement. As a resident of the neighbourhood for 8 years, I would like to express that I am highly supportive of this project for several reasons.</p> <p>Firstly, I believe that this project will be a welcome addition to Finchley road in terms of its aesthetic beauty. The proposals for Lighthouse will make this area very visually striking when exiting the Finchley Road tube station across the street. It will be a huge talking point.</p> <p>But far from a cosmetic perspective, this building is doing something unique and very significant for the community. One of the core partnerships that will occupy The Lighthouse, is XLP <a href="http://www.xlp.org.uk">www.xlp.org.uk</a>, who engage with many local teenagers, in the local secondary schools (including UCLA) and on the estates, Rowley Way, Wendling, Broadhurst and by Swiss Cottage. Through running after-school youth clubs and one-to-one mentoring, XLP practically interact with teenagers exposed to gangs, crime, poverty and anti-social behaviour, which is absolutely instrumental in helping support parents and local schools tackle these problems. We have great challenges in this area as a city, and a borough no less. The Lighthouse will be a place where youth can hang out, belong and attend after-school clubs. Meanwhile, the proposed recording studio that is being designed in the Lighthouse building is geared with local youth in mind. It will engage local youth through music, enabling them to train, learn and produce their own music. It will be an exciting investment in their talent.</p> <p>The Lighthouse is also going to be a home to the youth employment programme, Spear, helping 16-24 years from all different backgrounds into long-term employment. They have a 70% success rate of getting their students into jobs and remaining there for a minimum of 1 year after. Both XLP and Spear are practically helping transform the lives of so many young people in Camden, and having a proper resource and space in the Lighthouse building to do their work will enable them to do even more.</p> <p>The Lighthouse building is also helping to support our crippling care system, by offering a home for 7 young vulnerable adults, and a seasonal homeless shelter. Social services need support, and the church have already worked hard to meet the strict guidelines and requirements of the charities they work with (XLP and cw4s <a href="http://c4wshomelessproject.org/">http://c4wshomelessproject.org/</a>). The existing church staff have demonstrated a heart to work with the experts in these fields and really practically support their work. This gives me great confidence into how the building will be governed, managed and led.</p> <p>In addition the new building will be working hard hosting the local primary school, Holy Trinity Primary School, for their weekly gym and assembly classes.</p> <p>The current church 70s building is already maxed in its use. There is only 2 spaces - and has</p>
