T1-Japanese Maple-Rear-Large specimen. This tree is overshadowing entire garden and is encroaching on neighbouring properties. To improve light and air flow and to contain crown spread suggest: reduce crown by thinning by approx. 25%, reduce lateral growth encroaching over neighbouring boundaries by 25% (1-2m), remove Wisteria growing within crown, remove deadwood.
