**ENFORCEMENT NOTICE**

**ISSUED BY: THE LONDON BOROUGH OF CAMDEN**

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. **THE LAND TO WHICH THE NOTICE RELATES**

**Land at: 8 Manstone Road, London NW2 3XG** as shown outlined in black on the attached plan (“the Property”).

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

**Without planning permission:** The unauthorised installation of side dormer windows without planning permission

4. **REASONS FOR ISSUING THIS NOTICE:**

1. It appears the breach of planning control has occurred within the last 4 years.
2. The existing 2 side dormer windows, by reason of their design, scale and location, result in a prominent and bulky form of development which has a detrimental impact upon the character and appearance of the host building and streetscene and on the integrity of a largely unaltered roofscape of the group of properties on Manstone Road, contrary to policy CS14 of the London Borough of Camden Local

Development Framework Core Strategy, policy DP24 of the London Borough of Camden Local Development Framework Development Policies, and policy D1 of the Camden Local Plan Submission Draft 2016.

5. **WHAT YOU ARE REQUIRED TO DO**

Within a period of **four months** of the Notice taking effect:

- 1) To totally remove the existing side dormer windows and reinstate the roof of the main building, or
- 2) To totally remove the existing side dormer windows and make the development comply with the planning permission granted on 14/03/2017 under application reference 2017/0343/P
- 3) Make good any damage caused as a result of the above works.

6. **WHEN THIS NOTICE TAKES EFFECT**

This notice takes effect on **4<sup>th</sup> July 2017** unless an appeal is made against it beforehand.

**Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002**
