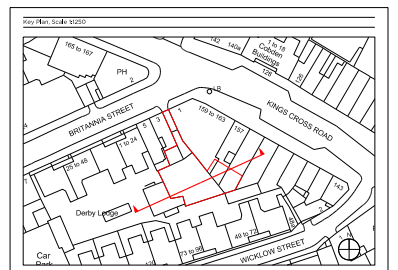


- 5. Risk/Action Note**
