The planting of the 4 Indian bean trees by the garden designer was rather excessive and now the trees are maturing they are over shading the beds and encroaching on the neighbouring Trees. The idea suggested would be to fell the rear two bean trees and keep the front two. Also the Silver Birch is starting to lean considerably due to the large Plane Tree behind and was also part of the "Over planting scheme". This has resulted in excessive shaded areas and the Clients would like to amend this.
