Thank you for your communication of 26th April 2017.

I can confirm that the planning applicant is in communication with London Underground engineers with regard to the development above. We have the following comments to make on this planning application.

1. Provision of Basement Services - additional details/information required, as the basement slab (Covered Way G143) is retained as part of the development and LU requires assurance loads from the services and types of refuses will not cause any detrimental effect to the integrity of the basements slab.

2. Variation to Condition 3 (method statements) to allow some above ground development to commence prior to the submission/approval of methods statement for the development proposed below ground level.

This amendment could be detrimental to LU and is a breach of the lease, as agreement states developer requires LU consent and approval for works which may have an impact of their infrastructure. The above ground development is reliant on the support and use of various elements below ground and at track level, and to receive and allow above ground works to proceed without awareness of proposals is irresponsible. In term of consenting to works, only activity LU will permit to commence is sift strip (removal of doors/windows/ bathrooms/ kitchens/stud partitions and other non-structural members) which must be listed/itemised.

Therefore we request that the grant of planning permission be subject to following conditions:

- Basement slab (Covered Way G143) to be retained as part of the development
- Provide assurance that loads from the services and types of refuses will not cause any detrimental effect to the integrity of basement slab

Reason: To ensure that the development does not impact on existing London Underground transport infrastructure, in accordance with London Plan 2015 and 'Land for Industry and Transport' Supplementary Planning Guidance 2012

We also ask that the following informative is added:

The applicant is advised to contact London Underground Infrastructure Protection in advance of preparation of final design and associated method statements, in particular with regard to: demolition; excavation and construction methods;
