I am writing in reference to your objection for the above Discharge of Condition application reference: 2017/2023/L.

This application is not a revision to any previously approved scheme, but for the approval of details, requested under condition 2 (a, b & c), to be submitted to the Council. Your objection is addressing concerns in terms of the proposed design of the shopfront, in particular the fascia area. The details relating to condition 2 are for the joinery and plasterworks, historic fabric repaired and retained required by listed building consent granted on 31/03/2017 (reference: 2016/6709/L).

Your comments on this latest application are not raising any kind of concerns relevant to the details provided to satisfy the Council's approval.
