Silver birch nos. 21 & 22 as shown on the attached tree removal plan (SJA TRP 16318-01). Following a survey of the site in November 2016, there were fungal fruiting bodies consistent with honey fungus (Armillaria mellea) observed at the base of the tree and as such were deemed to have only short-term potential. They are not readily visible from out side of the site and are therefore of low amenity value.
