- Outdoor air supply air handling unit providing make up air to cooking hoods for the ground floor restaurant. Plant to be positioned on the east roof area. (AHU 2.1.1)
- Extract fans for general kitchen, pastry hood (EF2.3.2) and feature cooking hoods (EF2.3.1 and EF2.3.3) positioned on the south west roof area. The pastry hood extract fan discharges to atmosphere at second floor roof level. The general kitchen and feature cooking hood extracts discharge to atmosphere at 9th floor roof level.

Plant description for 8th floor roof area:

- Replacement heat rejection air cooled package chiller plant; 2 No, 1 new to replace existing, 1 existing. Positioned on the open roof.
- Replacement guest room supply air handling unit (AHU8.2) and bathroom extract fans (EF8.3a and b). Positioned on the open roof, air intake and discharge to atmosphere via AHU 8.2 at 8th floor roof level.
- Replacement of Kitchen supply air handling unit (AHU8.1). Positioned on the open roof area, air intake at 8th floor roof level.
- Main cook hood and feature hood extract fans (EF8.4, 8.5 and 8.6) (3 No), new. Positioned on the open roof area, discharge air at 8th floor roof level.
