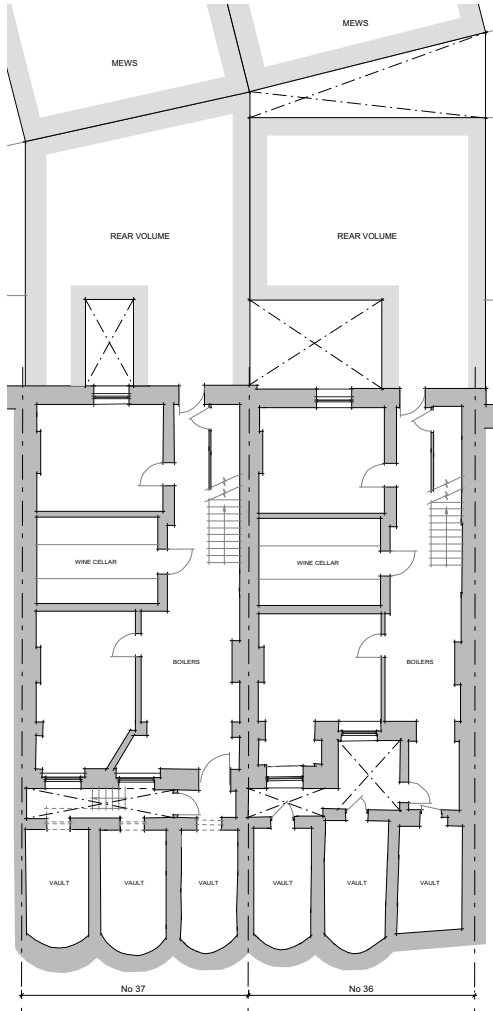

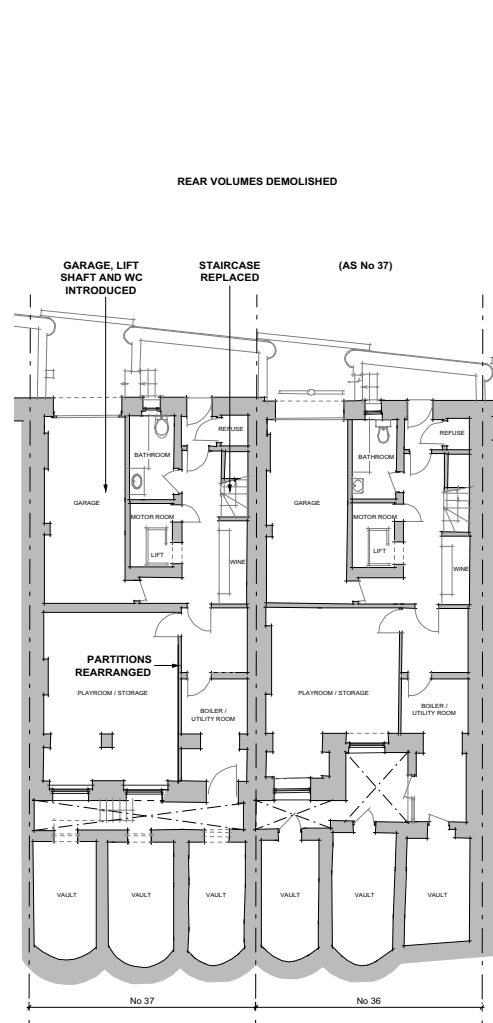

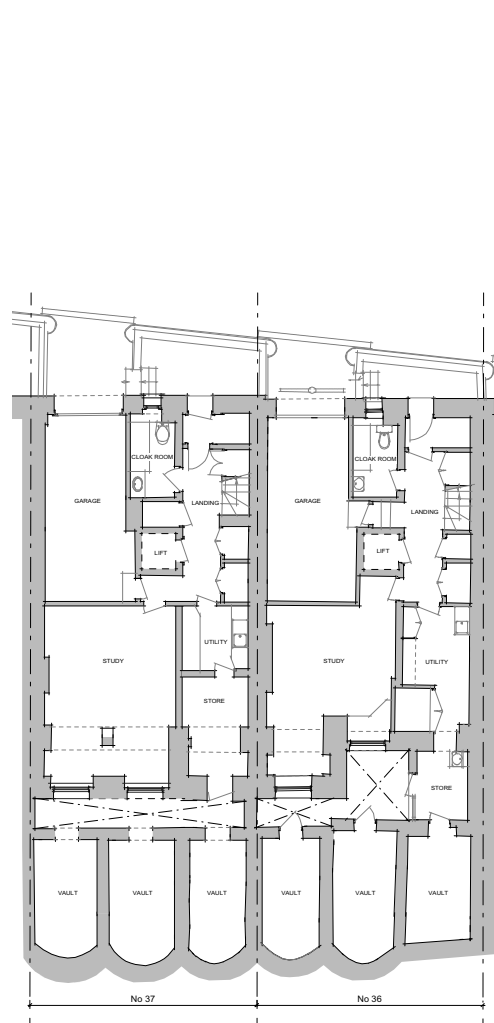

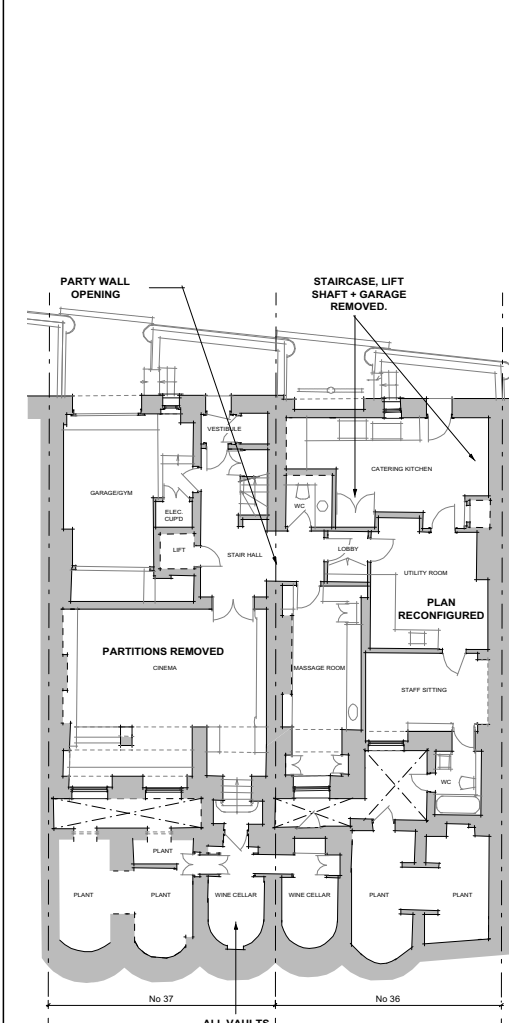

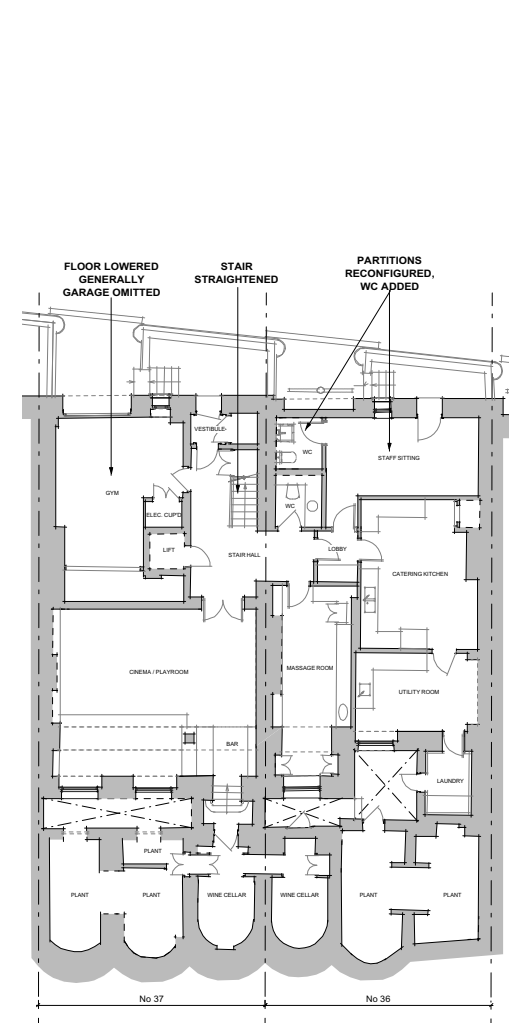

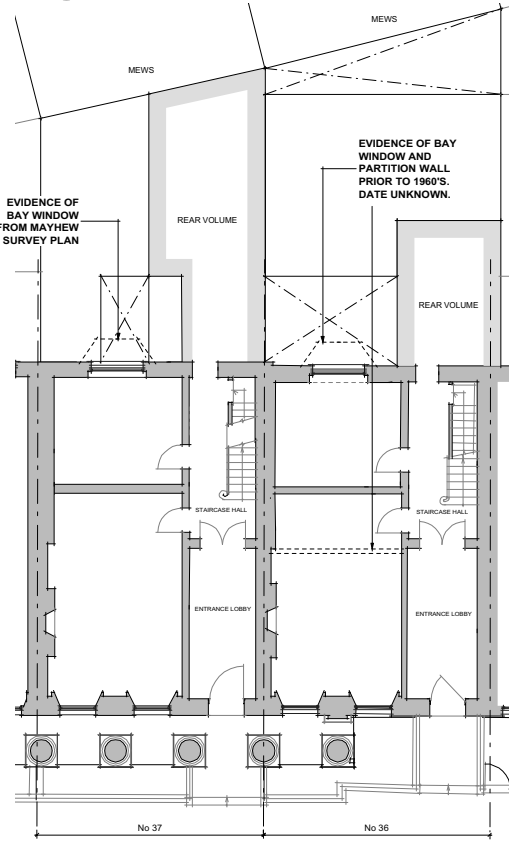


4 LOWER GROUND FLOOR PLAN YEAR : 2017 (EXISTING)

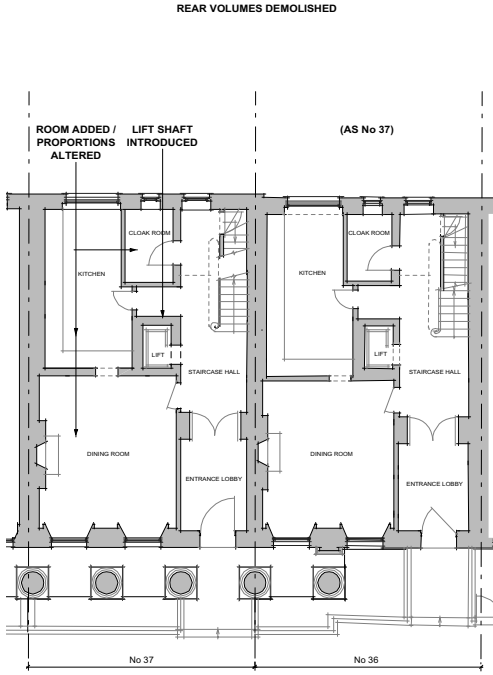

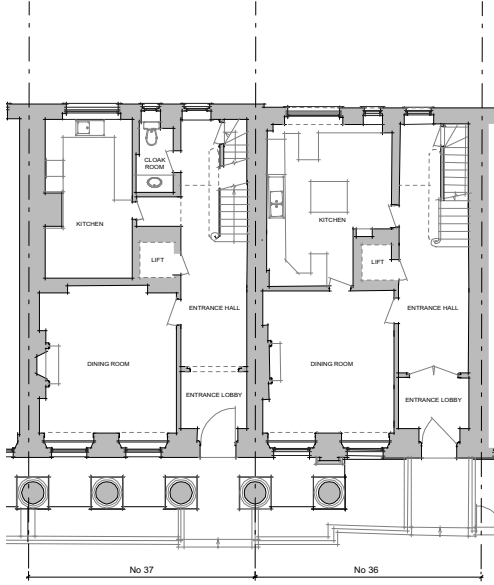
5 LOWER GROUND FLOOR PLAN PROPOSED

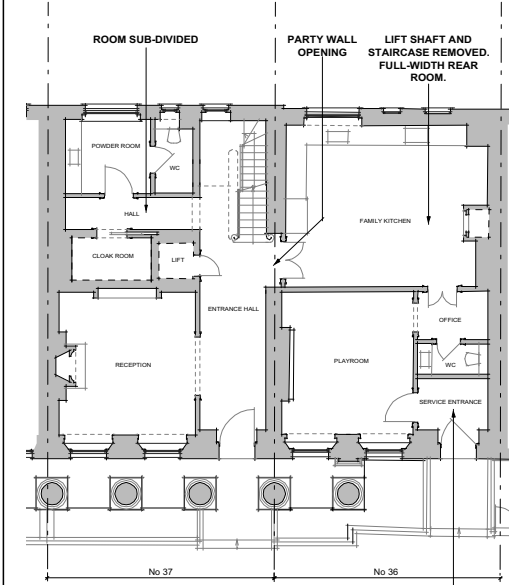
6 GROUND FLOOR PLAN ORIGINAL

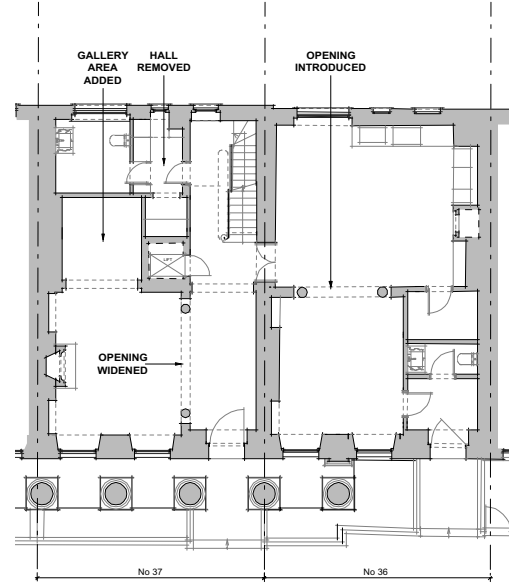
7 GROUND FLOOR PLAN YEAR : 1960's
