The proposed works involves the construction of a single storey ground floor rear and side infill extension to the rear of the ground floor flat. It will be constructed between the existing single storey extension and the side boundary wall. An existing access gate in the side boundary wall will be infilled with matching brickwork. The extension would be flat roofed and would extend 4.175 m from the original rear elevation of the house. It is designed to be less in depth and height than the existing single storey rear addition. The extension would incorporate a set of painted timber framed glazed doors and window to match existing. A rooflight would be inserted into the flat roof of the extension. The proposed works involves the construction of a timber, single storey, pitched roof outbuilding for ancillary use of the main flat
