Rear Garden : 2 x Lime tree - Crown reduce in height by 2-3m and laterally by 1-2m back to near most recent reduction points leaving furnishing growth.

And 1x Tree of Heaven - Fell to ground and treat stump.

1. The tree has outgrown its surroundings and leaning heavily away from the building towards the pavement and the road. It is leaning heavily on fence at the moment.

2. Due to its proximity to the building the tree does not have much earth mass to hold its progressively leaning weight.

3. Multiple cracks on earth surface (opposite to the way it is leaning) have appeared and that is concerning.

4. The tree is inherently weak in the lower trunk are due to an early life injury. The trunk size is nearly 16 inches of which injury is 11inch deep and 7in wide into the trunk's core. It is an decaying injury. This makes the trunk very fragile in the main load bearing area.

7. Identification Of Tree(s) And Description Of Works

5. The adjoining Lime trees provide very suitable screen cover and shade.

All of the above make this tree very unstable and unsafe for the pavement users, road users, vehicles parked close by, public property and for the 131 boundary wall. It is a matter of time before it falls under its weight either due to lack of hold or due to weak injured trunk in the main load bearing area of the trunk.
