To construct a new bin store 3.15m long, 1.1m wide & 1.4m high with hit & miss timber slatted doors, to house 5 bins (2 x green recycling & 3 black rubbish bins) to the new council dimensions to the left of the Main Front Entrance to the property. The construction is to be rendered and painted masonry, with shallow pitched roof to blend into existing surroundings. To reinstate capping stones to 8No; existing columns A & B which at present are without cappings, overlay main entrance pathway and steps with small black and white tile pattern finish. Replace 4No sets of steel railings, to match period design as shown in photo illustration. Existing garden store to lower entrance level to be modified with flat roof set back at lower level. Small low level landscaping to the front garden area adjacent to front wall.
