Prune London T14 Plane located at the Front Boundary according to the following specifications:

- Clean to remove all dead, diseased and broken branches 3 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure. An occasional dead branch larger than specified may be left where it is impractical to remove it.
 - Thin crown to remove approximately 20% of live branches to reduce risk of branch stem and/or root failure. Most thinning cuts will be between 3 and 5 centimetres in diameter.
 - Reduce crown spread and height by 2.5-3 metres to most recent points as part of a cyclic pruning process.
- Remove resulting debris.

Prune English Oak T16 located at the Front Boundary according to the following specifications:

- Remove epicormic growth to stem and thin new sprouting growth by thinning the growth
