T1 2 No Lombardy Poplar Populus nigra 'Italica' Rear Large, mature, previously reduced trees. Both trees are getting smothered in Ivy. The Ivy hides defects, fungal fruiting bodies etc. It also adds weight and sail to the crown. To reduce mechanical loading and to reduce the moisture uptake, the suggested works are: To reduce the overall height by 6 - 7m (approx. 2m below the previous reduction points), reduce the lateral spread all round by 2 - 3m, remove deadwood

2 No Ivy Common Hedera helix Remove Ivy down to approx. 4 - 5m above ground
