1. Silver Birch (*Betula pendula / alba*) Tall mature tree. To: Contain spread and improve light, space and clearance all round:Reduce crown in height by up to 2m to suitable new growing points and round off. Thin and clean out main crown, remove deadwood and suppressed growth.Lift canopy all round by up to 1m. Balance crown.
2. Ash (*Fraxinus excelsior*) Very large mature tree close to properties.To: contain spread and improve light, space and clearance all round and to maintain control of root activity. Reduce crown all round by 25-30% to previous reduction points. Thin and clean out crown, remove deadwood, weak and suppressed branches and sucker regrowth.Lift and balance crown.
3. Pink Chestnut (*Aesculus x carnea*) Very large mature tree, for the species. Not maintained for some time and carrying very heavy lateral limbs ( this species is often prone to limb shedding due to bacterial cankers within their make-up..) To: contain spread, lessen weight on branch ends and pre-empt potential for limb-shedding and to improve light, space and clearance all round:Reduce and re-shape crown by 25-30% all round to suitable new growing points, retain crown continuity. Thin and clean out crown, remove deadwood,weak and suppressed branches. Lift canopy all round by 1-2m. Balance crown.
