3. Description of the Proposal

Please describe the proposed development including any change of use:

The site of the works is a raised ground-floor 1-bedroom flat within a Victorian-era house which has previously been converted into four separate flats. The works consist of:

- 1) Removal of single-brick internal supporting wall separating the lounge and bedroom by the insertion of a suitable supporting RSJ beam. A new stud wall and doorway will be constructed such that the floor area of the lounge will be enlarged and that of the bedroom reduced in equal amounts.
- 2) Replacement of a large single-glazed metal-framed window at the rear of the property with a set of painted timber double-glazed French doors together with a wrought-iron Juliet balcony. The aperture for the French doors will be formed by dropping the cill of the existing window. (Continued *)

~~3) Removal of additional internal works such as the reinstatement of an original doorway from the communal hallway to form the new main entrance door to the flat, which will permit the blocking of the current entrance door. As a result the door to the bedroom can be removed giving a more spacious bathroom layout. Replacement of the single-glazed metal-framed bedroom window with a UPVC unit more suitable to a bathroom setting.~~

 3) Reinstatement of an original doorway from the communal entrance hallway to form the new main entry door to the flat.
 4) Removal of newly-redundant internal bathroom door; rearrangement of bathroom fittings to accommodate new boiler and washing machine. Replacement of single-glazed metal-framed bathroom window with a UPVC window.
 5) Relocation of kitchen within newly-enlarged kitchen/lounge room
 6) Rewiring including new consumer unit; new central heating system
