Dear John Diver, I would like to register my strongest possible objection to this planning application for a seven day market on the ThamesLink Forecourt - it is THE most terrible idea. West Hampstead is a good balance at the moment and the thought of imposing a seven day market on us is indefensible and intolerable.

An intensive fulltime commercial operation like this would impact on the amenities and small businesses in our area, not to mention the loss of a green open space which helps with the impact of the weekday travellers using our three stations morning and evening.

And then there is our wonderful current Saturday Farmers Market which has really established itself as an incredible positive and welcome weekly event with personal relationships with many of the stall holders, which are treasured - what's going to happen to all of them - are they to be just thrown out the door like unwanted rubbish? The market has finished by 2PM and it is all cleared away and the space left spotless - that sort of impact is good and proper.

There is further the health and safety aspect to be considered - rubbish and litter, half eaten food and the inevitable vermin etc. My experience of seven day markets in London is that they are not pleasant areas - we do not want this for West Hampstead.

Has the space at Swiss Cottage between the theatre and drama school been considered?

Please, please, please do not ruin West Hampstead with a seven day market trading from 7am and 8pm.

To whom it may concern,

we are strongly objecting to the proposal of the Thameslink forecourt in West Hampstead to be used as a hot food "to go" market 7 days a week.

West Hampstead has been badly over overdeveloped in the last 5 years with more still under construction. Camden Council have granted planning permission to massive developments without upgrading the local infrastructure. This very small area is now a **major transport hub** where a **vast number of commuters** cross every day between Thameslink station, West Hampstead overground station and Westhampstead Jubilee line station. At peak times there are so many people using the narrow footpaths that they actually spill out onto the road. I, myself was once pushed out onto the road by commuters coming towards me as there was not enough space on the footpath. How there hasn't been a serious accident yet is a miracle as I witness people running out in front of cars every day to cross over to one of the train stations.

**The only bit of wide footpath/space is the Thameslink forecourt, which should under no circumstances be blocked by traders of any kind.**

We live in Iverson Road a few meters away from the proposed food Market. Already the Saturday market causes huge disruption to people living locally with vans taking up residents parking spaces and indeed parking illegally on the Thameslink forecourt as well.

**This should not be taking place during the week at peak times.**
