ENFORCEMENT NOTICE

ISSUED BY: THE LONDON BOROUGH OF CAMDEN

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. **THE LAND TO WHICH THE NOTICE RELATES**

Land at: 29 Tottenham Street, London, W1T 4RP as shown outlined in black on the attached plan (“the Property”).

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

Without planning permission: Erection of a corrugated iron roof at rear upper ground/first floor level

4. **REASONS FOR ISSUING THIS NOTICE:**
 - a) The unauthorised development has occurred within the last 4 years;
 - b) The works that have been carried out, by reason of their design, materials and appearance form a discordant and incongruous alteration that causes harm to the visual appearance and character of the building and the Charlotte Street Conservation Area. As such, the works are contrary to policy CS14 (Promoting High Quality Places and Conserving our Heritage) of the London Borough of Camden Local Development Framework Core Strategy, and DP24 (Securing High Quality Design) and DP25 (Conserving Camden’s Heritage) of the London Borough of Camden Local

Development Framework Development Policies and Policy D1 (Design) and D2 (Heritage) of the Draft Camden Local Plan.

5. **WHAT YOU ARE REQUIRED TO DO**


Within a period of **2 (TWO) months** of the Notice taking effect:

1. Remove the corrugated iron roof at the rear upper ground/first floor level; and
2. Make good the recessed area after this element has been removed.

6. **WHEN THIS NOTICE TAKES EFFECT**

This notice takes effect on **8 AUGUST 2017** unless an appeal is made against it beforehand.

Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002
