7. Identification Of Tree(s) And Description Of Works

Justification for fells: owners feel that the row of limes have become overbearing in a small garden causing excessive shading; in felling 3x trees and crown reduce 3x remaining trees, they will still maintain screening along the rear boundary. They also have extensive plans to re-landscape the garden which will include planting numerous small ornamental flowering trees.

ALTERNATIVE OPTION:

T1-T6

-reduce crowns of all 6x trees by 30%(3-4m)(less on T3)

-raise canopy to 4m, remove all basal growth
