Reduce the trees in height by approximately 4 metres and spread by 2 metres. Remove all dead wood, hanging branches and one stem touching the boundary wall (safety - the trees have regularly been shedding branches onto the road and driveway beneath).

G2 - Group of Sycamore trees (overhanging from the neighbouring garden).

Laterally reduce, as necessary, so there is no overhang to the office roof light (to prevent bird droppings on the window).

G3 - Two False Acacia (overhanging from the neighbouring garden).

Remove all dead wood overhanging the boundary.

T1 - Holly.

Clip into a conical shape.

T2 - Bay.

Remove (as Gannoderma fungus/decay in base).

T3 - Bay.

Crown clean all crossing, dead and badly pruned branches.  
T4 - Ornamental Pear.  
Reduce height of tree by approximately 2 metres.
