We have been granted permission by Camden Council to build a side extension to our house and the tree which is in our neighbour's back garden - that is 75 Compayne Gardens, London NW6 3RS - needs to be trimmed to the boundary. I have consulted a tree surgeon who advised that it would be a straight forward job, done by simple trimming to the boundary.

He advised to file an application beforehand.

I am not able to identify the type of the tree I am afraid - possibly sycamore but cannot be sure. Apologies.
