To reduce the mechanical loading and to maximise the light, the suggested works are: To reduce the height and the lateral spread all round by 2 - 3m back to the previous points of reduction, retain shortened furnishing growth for crown continuity, remove up to 50% of fine internal growth, remove deadwood and basal growth, remove trunk growth up to the crown break.
